Chances to run in May's Primary Election attracts several candidates

Primary races for elected offices are already beginning to shape up in Austin and Scottsburg. Those interested in running have until May 7 to successfully operate campaigns and create support bases of voters. In Austin, two have already stepped forward to run for mayor. Maj. Lonnie Noble with the Austin Police Department is a Republican (R), and Brandon G. White, currently a City Councilman and a Democrat (D), are on the Primary Election list. Those filing to run for Austin City

Council seats include incumbents Joe Smith (D) in District 2. At-large incumbents, both Democrats, include Staci Mullins and Johnnie L. White. Newcomers who have filed are Democrat candidates Jimmy D. Turner, District 1; Rustie A. Miller, District 2; and Brandon L. Stagnolia, At-Large. Turner served two terms as a city councilman under then-mayor Doug Campbell. Incumbent Clerk-Treasurer Chris Fugate (D) has also filed. In Scottsburg, current Mayor Bill Graham (R) is seeking the

GOP nomination. Currently, Chuck Sebastian (D) is the only Democrat to have filed. Four Democrat incumbent City Councilmen have already filed. They are: Stanley A. Allen, District 1; Bill Hoagland, District 2; Karen L. Gricius, District 3; and Chuck Rose, District 4. Incumbent Clerk-Treasurer Jan Hardy (D) filed to retain her job. James D. Coomer (D) has filed for the City Council At-Large seat. Those seeking municipal offices must register with the County Clerk by 12 noon on February 8.

Interim judge for Scott Circuit Court continues in her duties

Judge Alison T. Frazier will continue in her role as Judge Pro Tempore for Scott Circuit Court in the foreseeable future. Judge Frazier was appointed to serve in the pro tem position by the Indiana State Supreme Court on December 13. The Supreme Court took the action after being advised by Judge Jason Mount that he would be unable to head the court for an unknown length of time. Asked for comment, Judge Frazier stated she planned to continue to fill the role of Judge Pro Tempore until further order of the Supreme Court. Both circuit and superior courts in Scott County are busy places, causing Judge Mount and Superior Judge Marsha Owens Hower to push for creation of a third court for the county for the last couple of years. Funding for that court was approved by the Indiana legislature last year.

across Southern Indiana maintain regulatory compliance during spring floods. She also teaches a course on flood safety for disaster responders. Board Votes 5-0 to Approve Superintendent's Contract...**Community Rallies for District 2 Superintendent Marc Slaton at December's Meeting**

The Scott County School District 2 Board of Trustees met for their regularly scheduled meeting on Tuesday, December 11, with Board President Jason Kendall opening the meeting.

Board President Jason Kendall announced to the standing room only crowd that anyone who wanted to address the Board would be allowed to speak for three minutes (each) until 6:30 p.m. at which time the window to speak would be closed. The large crowd was there in to speak on behalf of the Superintendent's contract that board was to vote on that evening.

Al Riggle, representing the Kiwanis, spoke in support of Dr. Slaton stating that the Kiwanis have worked closely with him to improve community through improving our kids. He listed many areas of continued growth through Dr. Slaton's leadership, including: student academic success, LES Blue Ribbon Award, the implementation of technology in our schools, Apple School Recognition, recognized as tech model for other schools, expansion of dual credit opportunities for students, partnering with business and service organizations to provide counseling for students, formed partnerships with SCSD 1 and Ivy Tech, strong supporter of CEASE and drug prevention programs, implementation of the summer meal program, character development programs, Life Literacy Academy, extended vision screenings, and has initiated improved security in all of our schools, going so far as to have a mock shooting scenario to provide a training exercise with first responders (medical, law enforcement, etc.) which serves as a model for other schools. Mr. Riggle stated that he is not aware of issues the Board has with Dr. Slaton, but he does know that Dr. Slaton has done an outstanding job in the District and in the community and that we have something special here that doesn't happen by accident.

Mr. Tim Payne stated that he wanted to introduce himself in order to validate his opinion. He is a former teacher, coach and administrator in Clark County (40 years). After retirement he went to ISU & IUS as lecturer and supervisor of student teachers. He stated that he has worked in all of our schools as a supervisor of student teachers and has worked with some of our students. He stated that Dr. Slaton has innovated several programs and has continued several programs. Mr. Payne suggested that the Board go to the DOE to see what they say about Dr. Slaton and about our schools since they are the ones that give the grade and they are concerned about the educational progress of our students rather than ballgames or band or anything else. He added

that if they give him a good grade, the Board should consider giving Dr. Slaton an increase in salary and if that is not possible, consider extending his contract tonight.

Mrs. Lori Croasdel, stated that she teaches District 2 students for Ivy Tech at MASP. She complimented the students' behavior and work ethic and thanked the Board for the opportunity to teach those classes. She added that she had children in Scott 2 for 21 years and has known every superintendent since Dr. Amick. She said that she has been concerned about the lack of Board support for superintendents for over two decades. She questioned what goals the Board has for Dr. Slaton that he has not met. She added that many are confused as to why he only has a one year contract, stating that she sure works better not having to worry constantly about whether she has a job.

Mrs. Croasdel asked how the staff can function when they know their leader has only a one year contract, adding that employees can thrive when they know who they will be working with and asked how a leader can lead if they are worried about the Board working with them. She stated that she has worked with Dr. Slaton longer than all of them had been on the Board and had never heard one negative thing about his integrity, leadership, etc. She believes him to be a remarkable leader for our community and that removing him would be devastating for Scott 2 and the entire community.

Mr. B.J. Best, said that he has been a part of Scott 2 for a long time, and the reason everyone was here was for Dr. Slaton. He cited the concern about declining enrollment referenced in past Board minutes and questioned whether not renewing Dr. Slaton, who has led the District in a good direction, would make parents or students want to come here. He added that the Board's decisions should not be based on whether or not they like an individual, or on any personal issue. He commented that not only is Dr. Slaton a good leader who has helped every one of us, but Mrs. Slaton is also a huge asset to Scott 2. Mr. Best questioned if the Board felt that something had to be done, why it hadn't been addressed in other ways. He closed by thanking Dr. Slaton for his support over the years and said he would hate to see him and his wife leave this district.

Mr. Chuck Rose, retired administrator for Scott 2, stated that he could go on and on about how much he appreciated working with Dr. Slaton and how much he respects him as a person, but didn't think that would be beneficial for the Board to hear over and over. He noted that he had been

contacted by several community leaders asking questions about what was going on in the District. He said he could answer some of the questions, such as whether the District was in bad shape financially, to which the answer was "no" and how the schools were performing under Dr. Slaton's leadership. He agreed with Mr. Payne about seeing what the state thinks of Scott 2. Mr. Rose provided data showing Scott 2 grades from the state compared to surrounding districts. Scott 2 scored a 3.0 g.p.a. with all other surrounding schools' grades being lower. He added that in 2014-15 the state transitioned to more rigorous standards and since that time Scott 2 was the only district that did not have a "C." He said that though he doesn't see this as the be all end all, this is what people who are looking for school districts see. He acknowledged how hard it is to sit on that side of table and make decisions as a Board and stated that he appreciates and respects that. He urged the Board to look at the data and listen to the community, stating that Dr. Slaton is the face of Scott 2.

Scottsburg Mayor Bill Graham spoke about the strong partnership the City has formed with the county schools and area manufacturers. Area industries need highly trained people and both Dr. Slaton and Mr. Manns have been an integral part of bringing Ivy Tech, Vincennes University and Indiana University to the Mid-America Science Park to provide this training, not only to our students but also to adults. He stated that this is the first time we have had that kind of presence in Scottsburg and that the relationships that have been built between the businesses and schools requires trust. He is concerned that with the retirement of the Scott 1 superintendent this partnership would definitely be in danger without Dr. Slaton.

2018 Lilly Scholarship recipient and SHS Senior Madelyn Shelton, stated that she represented the most important perspective, which is that of the students. Miss Shelton said that Dr. Slaton's leadership has provided students with many opportunities that they would not have had otherwise. She asked the Board to support Dr. Slaton to allow him to continue to lead students.

Mr. Kyle Mullins spoke as a teacher, coach, parent, and friend of Dr. Slaton. He thanked Dr. Slaton for his vision for Career and Technical Education in Scott 2 and all of the developments at MASP, adding that he is thankful for Dr. Slaton's support of programs, including football, that help reach students who may otherwise not be met and ensuring that each student has a pathway for success. Mr. Mullins went on to say that as a parent he

feels safe sending his kids here and is happy with the number of ECA's and classes his children have access to at Scott 2. He ended by thanking Dr. Slaton for all of his support, stating that as his family is struggling with some health issues and Dr. Slaton has kept in close contact with him, sending him scriptures and daily texts. Mr. Mullins said these are things that are not seen but are crucial, adding that he is fortunate to be under Dr. Slaton's leadership.

Mrs. Shelby Boley has taught at SMS for 15 years and worked at SSU for 8 years prior to that. She felt that she could speak for many teachers in saying that they feel supported by Dr. Slaton and have a good working relationship with him. She said that Dr. Slaton had visited her classroom more than any past superintendent and that he does a great job interacting with students. She added that Dr. Slaton is also very active and strong in our community. Mrs. Boley stated that as a parent, she felt very secure sending her daughter to Scott 2 and was grateful that she went to college with 36 credit hours right out of high school. She closed by saying that when you cut the leader out of a district, you are voting against our district and she feels that Dr. Slaton is a strong superintendent who deserves our support.

Sheriff Kenny Hughbanks stated that what Dr. Slaton does for students on a day to day basis is above and beyond, adding that what he has done with school safety is unheard of. He stated that as a parent of a child with special issues it was always easy to get to Dr. Slaton, the principal or even the Board. He closed by saying that he firmly believes Dr. Slaton has the kids' best interest at heart.

First Christian Church Pastor Matthew Craig stated that his family had returned to the area a year ago and having raised children elsewhere, could say that Scott 2 has a great system. He said that two of his adopted children have only been speaking English for 2 years and the support they have received has been awesome. He thanked Dr. Slaton, Mr. Brewster and all of the teachers they have been involved with adding that there is always room for improvement, but his kids have excelled and been supported here.

Board Member Ron Moore thanked the community stating that they had been helpful. He wanted to assure Mr. Best, who alleged that decisions were being made based on personal issues rather than performance, that this was not the case. He stated that the Board does not vote according to whether they like someone or not, but rather on whether or not they are doing a good job. He added that it is the job of the Board to challenge the superintendent. He noted that

the Board appreciates all Scott 2 employees. Mr. Mays agreed, adding that if it was personal it would be an easy decision. He stated that he appreciated everyone coming in, but knew how he was going to vote when he came in the door. Josh Mays also stated that he did not think anyone felt threatened with a one year contract and that if they did feel threatened they didn't have to sign a contract. He closed by saying he was on the Board when Dr. Slaton was hired and whether good or bad, Dr. Slaton always knows how he feels.

Christy Roberts stated that she felt the Board was completely transparent with where they stand but it may not be communicated because it is confidential. She stated that they have goals and Dr. Slaton knows what those goals are and just like with any other business everyone goes through performance appraisals and all strive to get better. She added that the Board has the same level of expectations across the levels of administration and the intent of the Board is to continue to improve and to challenge the administration and Superintendent to improve. She closed by saying that the public cannot know all of the conversations that take place during executive sessions, and that none of it is personal.

Board Member Andrea Soloe made a motion to renew Dr. Slaton's contract for 2019-2020. Mr. Mays seconded and motion carried 5-0.

Jason Kendall asked if any of the Board members had anything to add.

Ron Moore stated that although the Board appreciated the community and the public input, they do not make decisions based on public opinion because so many things go on that the public does not know about.

Dr. Slaton thanked the Board for their support and stated that he knows there are things to improve and vowed to continually strive to get better every day. Dr. Slaton addressed the large crowd, stating that it was humbling to see all of the faces in the room, some of whom he has worked with for 18 years and community leaders we have partnered with to improve the schools and community. He added that we have a great community and a great school system and that it was on display tonight. He voiced excitement about other communities looking to us because of the great things we are doing. He closed by saying that he couldn't say enough good about Scott 2 and the community and that he appreciated both.

Mr. Brewster asked for clarification for the record about whether Dr. Slaton's contract was for one year or longer. The response being that it was for one year.

Crash Claims Life of Madison Man

Scottsburg Downs North Harrison in MSC Contest, 58-52

Led by senior guard Mitchell Prince's game high 22 points, the Scottsburg Warriors posted a 58-52 home victory over the North Harrison Cougars in a Mid-Southern Conference matchup at historic Meyer Gym on Saturday (Jan. 5).

The win was the fifth straight for Scottsburg putting the Warriors at 9-2 overall and 4-2 in MSC play. North Harrison dropped to 4-6 overall and 0-5 in MSC games.

Prince was deadly from behind the three-point line (5-10 for the game) connecting on three trifectas early in the opening quarter, tallying 9 first half points. He collected two more treys in the second half and added 7-of-10 free throws. Prince's five free throw makes in the final quarter helped the Warriors maintain its slim lead. He also added 4 assists and 2 steals for the night.

Prince was joined by freshman forward Hayden Cutter with 13 points, 6 rebounds and 2 blocked shots; senior guard Jimmy Neace with 10-points; sophomore guard Treyton Owens with 8 points on two-3 balls along with 4 rebounds, 4 assists and 2 steals; and junior forward Nick Sebastiao with 5-points, 4-rebounds and 4-steals. North Harrison was paced by L.T. Hatton with 21 points, 8-rebounds and 3-blocks along with Braden Jenkins and Skyler Wenzel who added 10 points each.

"A good win for us because of the size and matchup problems North Harrison gave us," said Warriors third year head coach Brent Jameson. "It was a frustrating game at times because we missed several opportunities to extend the lead, but didn't because of some mental mistakes. Small things, but wins never come easy and we will review those errors and continue to improve. Mitchell (Prince) had the hot hand and our guys were able to find him. He was effective on the defensive end as well.

Treyton (Owens) had another efficient game hitting a couple of

3's at key times and making plays. He played with a lot of confidence."

The Warriors opened the game hot and led 11-4 after Prince's third 3-pointer but the Cougars would rally to outscore Scottsburg 11-6 to cut the lead to 17-15 after a quarter. The second quarter saw Scottsburg slowly increase its margin and lead by 9 points as the Warriors held the Cougars scoreless the final 2:38 of the stanza, taking a 29-20 advantage into halftime. Prince and Cutter combined for 17 of the Warriors 29 first half points.

The third quarter had the Warriors widen its lead to 34-22 at the 6:06 mark when Prince connected on a couple of free throws. But from that point on North Harrison would go on a 12-6 run, ending the quarter down by six points at 40-34.

The final quarter had North Harrison getting within 2 points with 4:00 to play at 45-43. But Prince would make two free throws and Cutter would add a basket to get the lead back up to 6 points with 3:19 to go. The Cougars weren't done and hit a three with 2:50 remaining, cutting the Warriors lead back to three. But just 15 seconds later Owens would drain a long corner trifecta to put the Warriors back up by six. The Cougars would not get closer then five points the rest of the contest. Prince had 13 points in the second half.

Statistically speaking, Scottsburg was 19-44 (43.0%) from the field; 8-20 (40.0%) on 3-balls and 12-21 (57.0%) from the free throw line. The Warriors had 24 rebounds; 13 assists; 13 steals; 3 blocked shots and 15 turnovers. Scottsburg had 17 fast break points; 11 points off turnovers and 2 second chance points. . .North Harrison was 22-49 (45.0%) from the field; 2-10 (20.0%) on 3-pointers; 6-13 (46%) from the charity stripe; had 33 rebounds (14 offensive); 16 assists; 7 steals; 4 blocks and 22 turnovers. The Cougars had 6 fast break points; 15 second second chance points; and 9 points off Warrior turnovers.

252 Individuals have been canceled due to Voter List Maintenance in Scott County

Due to the 2016 Voter List Maintenance (VLM) project conducted by the Secretary of State's Office, 252 registrations were recently canceled. All of the registrations had two VLM cards mailed to them by the State in 2016 and both were returned to the State with insufficient addresses. At the point, these voters were placed in an inactive status and was given time to activate it through two federal general elections. Of those changed to the inactive status, 252 did not get activated and were canceled.

Although the Scott County Clerk's Office followed all of the steps necessary to complete the 2016 VLM, the Clerk's Office is posting these names to give voters another chance to be registered for the next election by completing a new registration form either by coming to the Scott County Clerk's Office to register or by going online to www.indianavoters.com to process it online. If a new registration is not completed before the next election, these voters will not be able to vote on election day.

The Clerk's Office is located on the main floor of the Courthouse in Suite 120. The easiest way to get to the office is by entering through the south doors of the Courthouse and then stopping by the first window on the right.
