



Scottsburg Plan Commission to hear plans for new housing subdivisions

Two hearings involving proposed housing subdivisions off U.S. Highway 31 (Gardner Street) in Scottsburg will be held starting at 6 p.m. on Monday, May 17.

Both will be held at City Hall. The first hearing involves the Hidden Meadows Subdivision, the entrance to which is located off Cope Lane.

Developers want to create ten more include a hearing by the Scottsburg Advisory Plan Commission (SAPC) to consider primary approval of the subdivision on 5.4 acres.

The property is contiguous with and has access to the existing Hidden Meadows.

The second hearing will consider subdivision plat approval for 2.048 acres at 2220 U.S. Highway 31 South. Those developers want to create a small or minor subdivision for the purpose of disposing of the property. The ground is currently zoned Heavy Industrial and is located near Multi-Color Corporation.



Jefferson County Man Arrested for Child Molesting



Kent "Jason" Koehler

Police-Versailles arrested a Madison, Indiana man home. on an arrest warrant for two counts of Child Molesting. The investigation by Detective

Nathaniel Adams began in January of 2020 when the Indiana State Police was contacted after two children came forward and claimed they had been molested while at a residence in Jefferson

The suspect in the case was entified as Kent "Jason" identified as Kent "Jason" Koehler, age 48. During the course of the investigation, detectives learned that Koehler allegedly inappropriately touched two female children under the age Detectives from the Indiana of 14 on more than one occasion

At the conclusion of the investigation, the case was presented to the Jefferson County Prosecutor's Office for review. As a result, an arrest warrant was issued for Koehler on two counts of Child Molesting, Level 4 Felony.

Troopers located Koehler at his residence in Jefferson County, Indiana yesterday where he was taken into custody. Koehler was incarcerated at the Jefferson County Jail pending his initial appearance in court.





Public forum on county's needle exchange program informative and supportive of community

a May 5 public forum about Scott County's free needle exchange program. Scott is among nine Indiana counties which still operate a needle exchange, giving clean new needles to addicts in exchange for used ones.

Commissioners organized the public forum as they debated among themselves if the county should continue the program or drop it.

Statements offered that evening came from recovering drug addicts to respected medical professionals that included some local, state and national public health figures.

Everyone who spoke before the standing-room-only crowd supported the program that has provided clean syringes to those who request them since 2015.

Locally, nationally internationally, that year will never be forgotten. Scott County saw a sharp, sudden spike in the number of cases of HIV, a virus that can lead to deadly AIDS if not treated, and Hepatitis C, another deadly condition if not treated. Reportedly, both had traveled to Scott County via a visitor from Louisville, Ky., who traded needles with local drug abusers. Those addicts shared needles with others and suddenly, Scott County was in the national news as the source of the first recognized rural epidemic of HIV.

professionals from the Indiana State Department of Health (ISDH) travel and remain in Scott County for weeks. They helped staff of the local Health Department set up systems to help those afflicted.

Some of those people were at the Board of Commissioners' forum that Wednesday night. Several other speakers credited the local effort said. in helping them to turn their lives around.

It wasn't easy for any of them, their stories revealed. Yet one young woman told Commissioners that the needle exchange is an integral part of why she is alive, recovering and the mother of two healthy children.

The program is more than a needle exchange, they explained. It helps health professionals gain access to more drug abusers. "They see us as people, not a number, and they treat us as humans," one recovering addict stated.

Phil Stuckey, a former police officer and recovering addict, heads the Thrive program. He started off the nearly three-hour forum by explaining what Thrive does for those who come to meetings. He credited a group of locals who serve as coaches for people trying to wean themselves away from drugs with saving several lives. Next after Stuckey came Sheriff Jerry Goodin and former sheriff McClain. Both of them advocated to continue the needle exchange. "Look at the stats. This program works," Sheriff Goodin said, adding, "For the safety of this community, our children and for the prisoners, continue this program."

Dr. Kevin Rogers, Public Health Officer for Scott County, looked pale as he sat before Commissioners with Health Department Administrator Michelle Matern. Dr. Rogers was recently injured in a vehicle accident, but he felt strongly enough about the needle exchange that he decided to attend. He thanked all in the room for their enthusiasm and support and recognized out-oftown visitors Dr. Kristina Box, the current State Health Commissioner, and Dr. Jerome Adams, former State Health Commissioner who served as the U.S. Surgeon General during the Trump administration.

Dr. Rogers commented that he felt the needle exchange "...has been a Godsend to Scott County. It has enabled us to have access to people who weren't getting healthcare."
